SPECIAL PASS A Special Pass (SP) is a temporary pass which is issued by the Malaysian Immigration Department to allow foreign nationals which includes international students to extend their stay in Malaysia due to 'special' circumstances. If an SP is required, the international student via their educational institution needs to submit an application to the Malaysian Immigration Department through Education Malaysia Global Services prior to the expiration of their current pass. These applications must be accompanied by the relevant supporting documentation. It is the Malaysian Immigration Department's prerogative to issue an SP based on the reasons and justifications provided. Each SP is valid for a maximum of 30 days. Students who fail to apply for an SP prior to the expiration of current pass will be subjected to 'Overstay' fines as determined by the Immigration Department.

	Common Circumstances for a Special Pass	Example of Situations
1	Making Arrangement to Exit Malaysia This type of SP is granted in cases where international students need to extend their stay in Malaysia for less than 30 days (for instance, if the international student is not able to leave Malaysia before the expiry of their current pass). For this, the international student needs to provide a copy of the flight itinerary, showing the intended date of departure from Malaysia and if approved, the Immigration Department may extend the pass up until the intended departure date.	▪ If a Visa Approval Letter (VAL) and/or a Visa Approval Letter (VAL) appeal is rejected ▪ A Failed Post-Arrival VAL medical screening or appeal
2	Pending Approval for Student Pass (or other related Passes) For cases where the international students or dependents are in the midst of renewing their student/dependent pass in Malaysia, they may be eligible to apply for an SP to remain in Malaysia for up to a further 30 days beyond current pass expiry, pending the decision on the renewal application. In this case, the international student/dependent will need to furnish evidence to show that their application is in progress. If the renewal application cannot be completed within the validity of the SP, the international student/dependent may apply for a second SP. However, they may need to provide a copy of their flight ticket showing that they will depart Malaysia if the pending renewal application cannot be completed within the duration of the second SP.	▪ The Dependent would need to apply for an SP if the Principal student pass is still pending endorsement ▪ In the event that there is delay in submitting renewal application to EMGS, students may have to apply for an SP pending their renewal student pass endorsement ▪ If an Existing student pass or SP has expired ▪ Extending a shortened/cancelled student pass
3	Completing In-Country Immigration Process Upon arrival in Malaysia, the international student will be given an SP of up to 30 days period to remain in Malaysia with NO charge and within this time frame, they would need to complete the required immigration formalities to get the Student Pass. If the international student fails to complete the in-country immigration process within the time frame, they may then apply for an SP to remain in Malaysia whilst completing the necessary procedures.	▪ If the student is waiting for VAL Approval (Progression or Variation). The Malaysian Immigration Department may issue multiple SPs with a total cumulative duration of 90 days. ▪ An SP may be issued pending VAL Approval on appeal ▪ An SP may be issued pending Post-Arrival medical report / Post-Arrival medical appeal report ▪ An SP may be issued pending VAL amendment ▪ An SP may be issued if the student has failed the initial post-VAL medical screening
